### Discussion

- S. Ferguson If this isn't spent from this fund it will just sit there and grow? How much is currently in the fund? Can we use those funds anywhere else.
- G. Samia Yes, there is about \$2,130,000 currently in the fund
- B. Keegan We can only use the ambulance receipts towards ambulance related functions per statute. We evaluate this fund every year to see how we can use it to offset the budget.
- A. Berdos by having another ambulance it will bring in revenue which will further grow that fund.
- S. Ferguson I have heard push back on getting a 3<sup>rd</sup> ambulance and the answer is because we need it and because its revenue generating.
- C. Gallagher I believe the misconception is that Foxborough hasn't grown, haven't doubled in population in the last 10 years. Looking at Patriot Place and other commercial places in town we have grown and the level of service is affected and other towns are getting the calls that Foxborough can't answer because we lack a third ambulance.
- B. Yukna It will take 9 months to a year to get an ambulance delivered after its ordered. You also can have a fund that charges a fee and let the fund grow without putting that money towards the service that the fee is being charged.
