(DPW Building Repair and Maintenance Project)

(Personal Property Exemption Threshold Amendment)

ARTICLE 4:

(Acceptance of Souza Avenue as a Public Way)

To see if the Town will accept as a public way Souza Avenue, which has been constructed pursuant to the Planning Board Subdivision Control Regulations as follows; or to take any other action related thereto:

Souza Avenue – from its intersection with East Belcher Road generally northeasterly approximately 700 feet more or less to its intersection with Barros Lane.

(Acceptance of Barros Lane as a Public Way)

To see if the Town will accept as a public way Barros Lane, which has been constructed pursuant to the Planning Board Subdivision Control Regulations as follows; or to take any other action related thereto:

Barros Lane – from its intersection with Souza Avenue generally northwesterly approximately 800 feet more or less to its terminus at East Belcher Road.
